President – Steven Bigden-Russell

- Steven has been looking at how other established PTO's handle such things as chair event reports, communication, etc. to pass along to our next executive board (e-board).

Treasurer – Kim Rossman

- Current balance is \$766.57.
- PTO profit from Movie Night was \$ 462.66!
- It was decided to wait until the end of the school year (after clothing drive, Applebee's pancake breakfast, & Spring Fling Dance profit in) to write a check over to KM Elementary.

- A motion was passed to allow the treasurer to keep on hand a \$100 cash box. Our PTO bank account is set up to NOT allow cash withdraws, so it is difficult for the treasurer to quickly make up the cash box when needed without this in place. (Article VI, Section V, 11 added to Bylaws on 4/9/14.)

Administration - Dr. Mayer

- The KM student account has enough money to purchase 18-27 tablets or Chromebooks. The next generation of Chromebook is due out early this summer (possibly touch screen).
 - Classroom centers in each classroom would be created so students can interact with the devices. Teachers could instantly show the students places, people or things that they are learning about.
 - Eventually a center in the library would be created to serve as a multimedia center for additional student research.
